This new application, which includes an earned revenue strategy, of Neighborhood Trust's expertise allows us to reach more clients and have greater impact. As one employee at Five Guys Burgers in Times Square, one of the first Employer Solution sites, stated after working with a Neighborhood Trust Financial Advisor: "Before meeting with my Neighborhood Trust advisor I would pick up my check on Friday and be broke by Monday. Now I've opened my first bank account and I'm saving towards my goals. I feel more secure knowing that my money isn't going any-where unless I want it to. A bank account means something."
